
# **News For Pasture Rangeland & Forage**

Arizona is experiencing one of its driest years in recent history with nearly 99% of the state in some sort of drought. With the lack of rain, PRF policies have performed exceptionally well throughout the state. This has helped Farmers and Ranchers get through the extreme drought by putting more money in their pocket.

## **PRF** for Apiculture

The PRF policy is not only available for Farmers and Ranchers, Beekeepers are also eligible for the PRF program which provides a safety net for their income sources – honey, pollen collection, wax and breeding stock. Rather than reporting acres, beekeepers will report colonies. Alfalfa growers should let their beekeepers know they are eligible to sign up as well.

## **Important Dates**

- <u>July 1st</u> Final date to make changes or to transfer existing policy to FARM Inc. for DRP, LRP and LGM policies.
- July 15<sup>th</sup> Acreage reporting date for spring crops (beans, chile peppers, corn, cotton, ELS cotton and grain sorghum).
- August 15<sup>th</sup> Premium billing date for Spring and Fall crops.
- September 1st Premium billing date for PRF policies.
- October 31st Final date to make changes or add coverage to your fall crops.
- November 15<sup>th</sup> Final date to sign up or make changes to PRF policies.
  Acreage reporting deadline for PRF policies.
- November 20<sup>th</sup> Final date to sign up or make changes to citrus policies.
